



I declare that it is my free will and desire to perform some or all the activities offered by the Company CENOTES ZAPOTE- ECOPARK such as using zip lines, bicycling, scuba diving and swimming in cenotes under the following terms and conditions:

I state the following under oath:

1) I declare that I am legally over the age of 18 and as such, I am an adult in full possession of my physical and mental faculties and have not been misled to sign this document; explained and demonstrated in my native language, I have understood it and have signed the version in English.

2) I declare that I am completely healthy with no illness, injury or any other circumstance that prevents me from swimming in cenotes, diving, snorkeling, or cycling, however I am aware that an unexpected health issue could arise that could cause me bodily harm or death; I assume exclusive responsibility for this as I am aware of the risk involved. I am physically able to perform these activities as I have not consumed alcohol, drugs or any medication that might alter my physical capabilities and in any case, I assume the risk that this implies. I give up the right to take action against CENOTES ZAPOTE- ECOPARK or any other person, and take responsibility for any consequences that may result if I should require or take any medication provided by the staff of the Company, in the knowledge that it will be at my own risk.

3) I declare that the activities that I will undertake, the territorial limits of where I will be taken, and the natural risks I face on undertaking these activities have been fully explained to me, and that I personally assume the risks implied.

4) I hereby assume any kind of criminal or civil liability, or any kind that may be caused by the activities undertaken, whether I am directly or indirectly involved in an accident. In case of the aforementioned occurring, I now take full responsibility for any damage caused of third party assets or property, including the equipment which I will be responsible for, as well as damage to any other party.

5) In case of an accident or failure to comply with the security measures, policies and conditions set forth herein, CENOTES ZAPOTE- ECOPARK shall have the right to terminate my tour at any time without refund.

6) I am aware that CENOTES ZAPOTE- ECOPARK does not control the natural habitat of some species of plants, animals and insects, that I have been told not to touch any of these, and so remove any responsibility from CENOTES ZAPOTE- ECOPARK, if an accident of this nature occurs.

7) In activities related to zip lines and the use of facilities, I am aware that it is forbidden to jump from heights or places where it is not allowed, and so if I fail to comply, it will be at my own risk and responsibility, and my activities will be suspended.

8) I declare that I am aware of the cenote swimming safety procedures, as well as the territorial limits of where I am allowed to swim and I commit to respecting them, as this activity involves high risk due to the rocks and caves where I swim. I also declare that I am fully qualified and experienced enough to swim in these places. I am aware that the zip line drops in cenotes are at my own risk and therefore I accept that in case of any injury I will have to cover the costs required, as this is an optional activity and I was informed of this. I also agree that it is mandatory to wear life jackets during any water-based activities.

9) In all activities related to the use of bicycles, I agree with the mandatory use of a helmet and will follow the guides instructions at all times to prevent accidents. I accept full responsibility if I do not follow these guidelines.

In this act and for any incident, accident or event that occurs and might cause damage to myself, third parties or any material asset, I hereby release CENOTE ZAPOTE- ECOPARK of all responsibility, as well as any of its employees, legal representatives, subsidiaries, agents, administrators, shareholders or employees or anyone connected with the provision of this service.

10) In this act I also assume and take responsibility for any accidents that might occur while being on the grounds of CENOTES ZAPOTE- ECOPARK or when using the equipment and facilities, independently of whether the accident is indemnified or the medical expenses have been covered, releasing CENOTES ZAPOTE- ECOPARK and/or any other person from now of any civil, criminal or any kind of liability for accident or incidents. I assume any risk or consequence that could result, agree that I am physically and medically able to perform such activities and that all facilities meet all necessary security measures.

11) I agree to submit to the applicable law and jurisdiction of the courts of the state of Quintana Roo in Mexico for all matters relating to the interpretation, compliance and execution of this document that reflects my will, and expressly waive any forum, court, right or legal action permitted due to my nationality or present and future address.
